STATEMENTS ON FAITH AND PRACTICE

The doctrinal basis of Evangel Christian Academy is that biblical system commonly called “The Reformed Faith” as expressed in the Westminster Confession of Faith together with its Larger and Shorter Catechisms. In this light, we in our educational program stand committed to the teachings of the Westminster Standards and no other belief system may be taught as true. Though we do not require teachers to agree to all of the Westminster Confession, we provide this statement as a basis for our system of beliefs.

We require that teachers, administrators, and staff have a credible testimony and a commitment to salvation being found through faith in Jesus Christ alone. All employees must agree to the statement of faith found below.

As a corollary to our Statement of Faith, Evangel Christian Academy affirms that our faith has very practical implications. We believe these need to be stated in the context of our desire lovingly, yet Biblically, to represent Christ and His kingdom here on earth.

In order to preserve the mission and integrity of Evangel Christian Academy as a local expression of the Body of Christ, and to provide a Biblical role model to the students and the community, it is imperative that all persons employed by the school should agree to, and abide by, our “Statement of Faith” and “Statement on Marriage, Sexuality, and Gender Identity.”

STATEMENT OF FAITH

Evangel Christian Academy believes...

- The Bible is the written word of God, inspired by the Holy Spirit and without error in the original manuscripts. The Bible is the revelation of God’s truth and is infallible and authoritative in all matters of faith and practice.
- In the Holy Trinity. There is one God, who exists eternally in three persons: the Father, the Son, and the Holy Spirit.
- That all are sinners and totally unable to save themselves from God’s displeasure, except by His mercy.
- That salvation is by God alone as He sovereignly chooses those He will save. We believe His choice is based on His grace, not on any human individual merit, or foreseen faith.
- That Jesus Christ is the eternal Son of God, who through His perfect life and sacrificial death atoned for the sins of all who will trust in Him, alone, for salvation.
- That God is gracious and faithful to His people not simply as individuals but as families in successive generations according to His Covenant promises.
- That the Holy Spirit indwells God’s people and gives them the strength and wisdom to trust Christ and follow Him.
- That Jesus will return, bodily and visibly, to judge all mankind and to receive His people to Himself.
- That all aspects of our lives are to be lived to the glory of God under the Lordship of Jesus Christ.

STATEMENT ON MARRIAGE, SEXUALITY, AND GENDER IDENTITY

- We believe that every person must be afforded compassion, love, kindness, respect, and dignity. Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the policy of this school. (Ephesians 4:29-32)
- We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Genesis 1:26-27) Rejection of one’s biological gender is a rejection of the image of God within that person.
- We believe the term “marriage” has only one meaning and that is marriage sanctioned by God which joins one man and one woman in a single, exclusive union, as delineated in Scripture. (Genesis 2:24; Mark 10:6-8; Ephesians 5:25-33)
- We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other. We believe that God has prohibited intimate sexual activity outside of a marriage between a man and a woman. (1 Corinthians 6:18-20)

STATEMENTS ON FAITH AND PRACTICE

- We believe that any form of sexual immorality (including adultery, fornication, homosexuality, lesbianism, bisexual conduct, bestiality, incest, pornography, and attempting to change one's biological sex or otherwise acting upon any disagreement with one's biological sex) or advocacy of sexual immorality, is sinful and is therefore offensive to God. (Deuteronomy 22:5; I Thessalonians 4:1-12)
- We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ. (1 John 1:5-10)

Final Authority for Matter of Belief and Conduct

The statement of faith does not exhaust the extent of our beliefs. The Bible itself, as the inspired and infallible Word of God that speaks with final authority concerning truth, morality, and the proper conduct of mankind, is the sole and final source of all that we believe. For purposes of Evangel Christian Academy's faith, doctrine, practice, policy, and discipline, our board of directors is ECA's final interpretive authority on the Bible's meaning and application.
